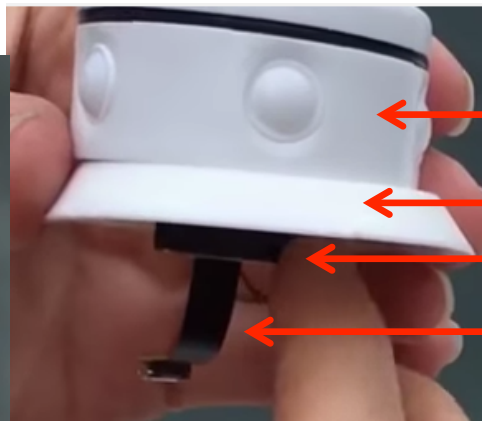

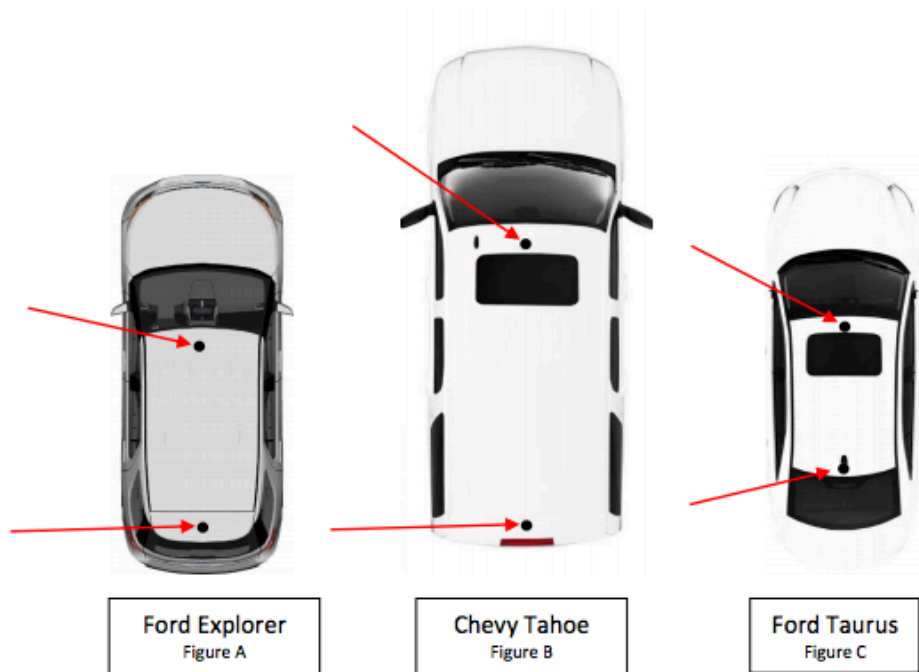

Refer to the diagram below before installing StopAmbush



These images are not to scale and for reference only.

The arrows point to the approximate pod position for each vehicle. These are the manufacturer's suggested position placements for optimal system effectiveness. Installation may vary depending on the structure of each vehicle.



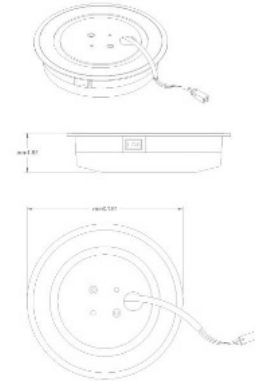
Ensure that no antennas or ancillaries are attached to the roof on the front and side of the pods (indicated by the shaded area in Figure D).

Instructions



1. Inside of the front of the vehicle, remove the dome light and locate the sheet metal roof under the liner.



2. Using a $\frac{9}{16}$ inch metal drill bit, drill a hole through the center of the sheet metal.
3. Partially remove the rear liner closest to the rear windshield.
4. Locate the center of the roof laterally and measure at least $6\frac{1}{2}$ inches or more back from the edge of the rear top gasket of the rear windshield. Drill a $\frac{9}{16}$ inch hole through the sheet metal.
5. Going back to the front hole, locate any 12V power source wire inside the roof liner connected to the dome light. Connect the positive wire (red) to the source and the negative wire (black) to a negative line.



6. Insert the wire harness over the top of the liner to bring the longest small connector (micro USB) to the rear of the vehicle and the short one in the area of the front hole by the dome light.

Lock the Sensor unit in place plug in the micro USB.

7. Loosen the driver side sun-visor to allow for the display wire to be *carefully* snaked approximately 4 to 5 inches out from under the liner.

8. *Carefully* snake the display connector over the liner and through the front area of the right side mount of the sun-visor.

BE GENTLE WITH WIRING TO AVOID DAMAGE



9. Using a second person and **extra care** with the micro-USB connector on the sensor, drop the threaded section of the sensor through the predrilled $\frac{9}{16}$ inch hole.

10. Align the sensor with the lock screw following the longitudinal axes of the vehicle and the middle sensor facing forward. Lock the unit using the locking screw attached (Assure proper setting of the gasket). Repeat the step with the rear sensor screw facing forward with the longitudinal axis and the middle sensor

pointing rearward.

11. Connect the male micro-USB into the sensor female connector assuring a proper connection.
12. Re-install the sun-visor, and before completely tightening the right-side mount slide the bracket of the display under it and fasten in place.
13. Insert the wide connector into the display female connector located at the top of the display.
14. Using the side slide power switch turn StopAmbush on and conduct testing before locking the liner and the dome in place.



Specs:

White Button:

Front top center-standby/deactivate mode with amber light next to it ON.

POWER switch:

Located on the side, when the switch is slid, the entire device powers on.

Yellow Buttons:

Up/Down volume control
